OPENING REMARKS



Alyona Getmanchuk, Director, New Europe Center Despite significant internal political changes in Ukraine in 2019, the New Europe Center continued to consistently follow its mission and three strategic priorities, which you can read more about in this report.

Through the discussion platforms we organized and the analytics we presented, we were actively present at the same time in Kyiv, in the regions of Ukraine, and in the European capitals. The effect of such a 3D presence allowed us to understand what the real demands for foreign and security expertise outside the Kyiv office were and to respond accordingly.

We are proud that in 2019, we have finally implemented our long-standing concept: we have evaluated the level of European integration of ALL regions of Ukraine. According to the indicators developed in partnership with the Government Office for Coordination of European and Euro-Atlantic Integration of Ukraine, we have created a full-fledged European Map of Ukraine, a ranking of regions in terms of their proximity to the standards, norms, and practices of the European Union. Discussion of "The European Map" results still continues in various regions of Ukraine.

In 2019, we succeeded in implementing our other analytical idea, to assess for the first time how Ukraine is implementing NATO standards. Not at the level of political declarations, but in the language of the relevant facts and their analysis.

It is important that our research and recommendations continue to be developed at the appropriate request of the authorities, as was the case with the previous President and Minister of Foreign Affairs of Ukraine, as is the case with the current Head of State and head of foreign policy authority.

We have significantly expanded our partnership with foreign, especially European and American, think tanks: we organized study visits for Western opinion leaders to Ukraine, co-authored analytical comments with colleagues from foreign think tanks, and cosponsored public events in Ukraine and abroad.



Last year became a record breaking one for the New Europe Center in terms of our presence in the global media. The Centre's expert publications and comments have appeared in almost all major printed media in the world, from The New York Times and Foreign Policy to The Guardian and The Wall Street Journal, from Newsweek and The New Yorker to Reuters, The Financial Times, and Forbes.

Following the principle of building a star team rather than a team of stars, we actively continued to engage the younger generation of analysts and researchers in the activities of the Center. Part of today's Center team is our interns and volunteers of yesterday.

Most of what we have accomplished in 2019 has been driven not only by the support but also by a full-scale partnership with our partners tested through time and joint projects, notably the Embassy of Sweden, Pact, USAID / ENGAGE, the International Renaissance Foundation, BST, and GMF.

The New Europe Center is increasingly referred to simply as the New Europe, omitting the word "Center" even in rather formal communication. We do not mind, because the association of us with New Europe as a whole, and not only with a single think tank, underlines once again the importance of our mission, which we will continue to follow with great responsibility and inexhaustible energy in 2020.

NEC ANALYTICS IS USED AT THE NORMANDY FORMAT NEGOTIATIONS

"We got used to assistance becoming more and more conditional," said Alyona Getmanchuk, director of the New Europe Center, a Kiev-based think tank. But she noted that conditions imposed in the past were about "helping Ukraine move forward and reform itself" — including encouraging the Kiev government to provide more transparency or adopt new national security measures that would further integrate it with the United States and NATO.








NEW EUROPE AND NEW FORMATS

Kateryna Zarembo, associate analyst at the NEC, co-authored an online course "European Foreign Policy: Complicated Things in Simple Words" on the Promethus platform. Among the guest speakers were Hugues Mingarelli, former Head of the EU Delegation; Ivanna Klympush-Tsyntsadze, Deputy Prime Minister for European and Euro-Atlantic Integration in 2016-2019; Barbora Maronkova, Director of the NATO Information and Documentation Center in Ukraine; Leo Litra, senior research fellow at the NEC.





Ukrainian diplomats actively use the NEC analytics to develop public policies. NEC prepares analytical documents with recommendations at the request of the Ministry of Foreign Affairs of Ukraine. The New Europe Center's Annual Club has once again become a platform for establishing relations between the authorities and experts. Moreover, it was the first event since the presidential election in Ukraine, where the representatives of the think tanks were able to communicate directly with the representative of the new administration, namely the Minister of Foreign Affairs of Ukraine Vadym Prystaiko, then Deputy Head of the Presidential Administration.



RECOGNITION FOR THE COMMUNICATION OF THE EUROPEAN CHOICE

Deputy Prime Minister for European and Euro-Atlantic Integration of Ukraine Ivanna Klympush-Tsyntsadze expressed her gratitude to the NEC "for the popularization of the European integration course of the country and the benefits of implementing the EU-Ukraine Association Agreement in Ukrainian society." NEC's research "The European Map of Ukraine. Rating of European Integration of Regions" was developed on the basis of the Memorandum on Joint Activities with the Government Office, and the new Vice Prime Minister for European and Euro-Atlantic Integration of Ukraine Dmytro Kuleba presented this research together with the NEC on November 11 in Kyiv.



Recommendations to the new government

The New Europe Center was ready for a change in government. As the new President made his inaugural speech, our analytical team presented detailed foreign policy recommendations for the leadership. The "ZeDiplomacy" cycle of publications by the director of the New Europe Alyona Getmanchuk was designed as a sort of a crib note for the new leader on priority foreign policy issues. An opinion poll conducted among influential foreign analysts reflected the Western governments' expectations of Ukraine's new authorities.

Countering Russian influence

The Center's analysts have prepared a series of case studies to analyze the success stories in counteracting Russian subversive activities in the individual EU countries. For example, Leonid Litra prepared a study "Counteracting Russian Influence in France," Kateryna Zarembo examined the situation in Poland, and Sergiy Solodkyy analyzed the cases of Germany and Hungary. These documents formed the basis of a comparative analysis presented to the Ministry of Foreign Affairs.

Leonid Litra has prepared a number of analytical materials on the situation in Moldova (namely the change of government) and the Transnistrian settlement. These documents attracted great interest among colleagues in the









Third powers in the Europe's East

The New Europe presented the results of a study of the interests of "third powers" in the Europe's East (China, Turkey, Israel, and Arab states) in the Eastern Partnership countries, in particular in Ukraine. This publication was prepared by the EU Institute for Security Studies (EUISS, France). Ukraine could benefit from the access to new markets and overcome common security challenges together with the "third power" countries. However, our state should also understand the potential threat that China, Turkey, Iran, etc. may pose to the EU's regulatory power.

Security in the Eastern Partnership countries

The NEC's analysts have been actively involved in developing the analytical documents and in discussing decisions to strengthen the European Union's policy on the Eastern Partnership countries, especially on Ukraine, Georgia, and Moldova. For instance, Leonid Litra joined the relevant events in Kyiv, Brussels, and Tbilisi. Sergiy Solodkyy participated in the debates on the EU policy issues in France and Germany.

THE EUROPEAN MAP OF UKRAINE. RATING OF EUROPEAN INTEGRATION OF REGIONS

The New Europe Center's project of the year is a unique research material "The European Map of Ukraine. Rating of European Integration of Regions" prepared by analysts of the Center in cooperation with the Government Office for Coordination of European and Euro-Atlantic Integration. "The European Map of Ukraine" is a rating of regions of Ukraine, compiled on the basis of their compliance with the indicators that, in our opinion, most clearly reflect the dynamics of rapprochement of individual regions of our country with the EU.

The first research of its kind. "The European Map" is the first comprehensive study of Ukraine's progress towards European integration. Overall, the evaluation was conducted in eight areas with 34 indicators. Thousands of figures have been processed by the NEC's analysts according to a specially developed methodology. Most of the data, published for the first time, have been obtained through hundreds of verbal and written requests to the authorities (primarily to Regional State Administrations).

Presentations in the regions. This research has attracted keen interest in the regions, and thus, in addition to the scheduled presentations in Kyiv and Dnipro, the New Europe Center also presented "The European Map" in Chernivtsi at the invitation of the Chernivtsi Regional State Administration. Two open discussions of "The European Map" were organized in Zaporizhzhia, and we continue advocating this







COMMUNICATING UKRAINE IN THE EU AND THE US



In March, the New Europe Center organized the twelfth study visit for Western opinion leaders to Ukraine in the last five years. This trip was supported by the German Marshall Fund of the United States (BST GMF) and the Foundation Open Society Institute (FOSI) in partnership with Chatham House. 14 participants from Germany, France, the United Kingdom, Belgium, the Netherlands, Italy, and Romania met with Ukrainian government officials, public figures, leading journalists, MPs, and representatives of international organizations and diplomatic institutions working in Ukraine.



On December 9-13, 10 German analysts visited Ukraine within a framework of a study tour of the German-Ukrainian Researchers Network (GURN). This project is being implemented by the New Europe jointly with the Institute for European Policy (Berlin). As a part of this initiative this year, a series of events will be organized, where Ukrainian stakeholders will be able to learn firsthand about the latest political trends in Germany and Ukrainian-German relations.



During the year, the New Europe's analysts met with foreign diplomats and politicians responsible for the Ukrainian direction. For instance, on May 30, Alyona Getmanchuk took part in a meeting with German Foreign Minister Heiko Maas. On June 26, the New Europe organized an event at the residence of Romanian Ambassador Cristian-Leon Uurcanu to summarize Romania's presidency at the EU Council. On September 30, Leonid Litra met with Brock Bierman, Assistant Administrator of the United States Agency for International Development (USAID), Head of the USAID Bureau for Europe and Eurasia. In November, Alyona Getmanchuk and Sergiy Solodkyy met with Hans-Jürgen Heimsoeth, Special Representative for the Eastern Partnership of the German Ministry of Foreign Affairs to discuss the future of cooperation between Ukraine and the EU.

INSTITUTIONAL DEVELOPMENT

Presentation of strategic priorities. The annual New Europe Center Club took place on July 10. This format allows to discuss the further development of the organization and to listen to key partners in an informal atmosphere. Representatives of the Ministry of Foreign Affairs, Administration of the President of Ukraine, colleagues from other think tanks, journalists, and representatives of donor organizations joined the discussion of the future of our organization.

Collaboration with the world's leading think tanks. In 2019, the NEC's analysts co-authored three analytical comments with Chatham House experts and a research in collaboration with the German think tank ZOiS, and organized a study visit of 10 German researchers to Ukraine within the German-Ukrainian Research Network (GURN) together with the Institute for European Studies (Germany). Senior research fellow Leonid Litra participated in the "Reviving the Eastern Partnership" workshop in Brussels at the invitation of the European Liberal Forum. Associate analyst Kateryna Zarembo has provided an expert commentary for the CIDOB think tank (Barcelona).

Financial transparency. The New Europe Center has successfully passed the annual financial audit.

The New Europe shares knowledge. Analysts at the New Europe Center conduct trainings in writing analytical materials within the program of the International Renaissance Foundation. The New Europe Center organizes events at higher education institutions. For example, the Institute of International Relations at Taras Shevchenko KNU hosted panel discussion "Hybrid Threats: Ukraine's and NATO's Response." Students from the Ukrainian Leadership Academy also visited the New Europe to learn more about the activities of think tanks and European integration.

Internship at the New Europe Center. The New Europe Center actively engages students and future analysts from both Ukraine and abroad in its activities. Due to the Think Tank Development Initiative (TTDI), Marianna Fakhurdinova, who has become a communications manager and analyst at the NEC since July 2019, was able to complete an internship at our think tank. Moreover, Mykhaylo Livaryuk, Victoria Omelyanenko and Kateryna Boyko were trained at the NEC within the framework of the educational project of the Reanimation Package of Reforms and the Center for Democracy and Rule of Law "Open University of Reforms".

Training of the New Europe representatives. Tetiana Levoniuk has completed an internship at the Slovak Foreign Policy Association with the support of the Renaissance Foundation. Marianna Fakhurdinova interned at the Ukrainian Embassy in Berlin.




COMPLICATED THINGS IN SIMPLE FORMATS



THE NEC'S MISSION IS RELEVANT





Most respondents (over 95%) consider the mission and priorities of the NEC's activities relevant to the current challenges faced by Ukraine.


According to our partners, in 2020, the New Europe Center should focus on developing recommendations to enhance the effectiveness of Ukraine's foreign and security policy (80%). In addition, the NEC should continue working on an advocacy campaign abroad on the situation in Ukraine (64%).






EVALUATION OF THE COMPONENTS OF THE NEC'S ACTIVITIES (ON A FIVE-POINT SCALE)


